## Safety Alert Issued by the UKMHA after a Jacking and **Blocking Incident**

The incident happened when the engineer jacked up a reach truck to check for free play in the steering bearing fitted to the top of the final drive gearbox. The engineer held on to the drive wheel in order to check for excessive play in the bearing.

The truck slipped off the jack and trapped the third and fourth finger of the engineer's right hand between the wheel and the floor. The injuries to engineer's hand included cuts, crushing and fractures.

The truck was only supported by the jack at the time of the incident. It had not been lowered onto supporting blocks, leaving the jack as the only load support for the task, which is unsuitable equipment to carry out this task.

The UKMHA safety alert identifies a number of contributory factors for this particular incident, including inappropriate equipment, inadequate training, failure to ensure a safe working area and a lack of proper job planning.

David Goss, Technical Director at UKMHA said: "No work should be carried out under any load that is

supported by a jack. Failure to ensure adequate support of the load was very hazardous, and this incident could have led to far more serious injuries."

He continued: "Our safety alert provides advice for those maintaining and servicing material handling equipment. We advise them to follow the guidelines as laid out in the safety alert and the associated jacking and blocking safety awareness video.'

The UKMHA plays a vital role in promoting improved safety standards within the material handling industry in the UK. The key aim is to ensure that the safety of its members and the wider industry is of paramount importance.

Company and Director Sentenced after Employee Crushed to Death



The worker was crushed by two granite slabs while working for West Midlands firm on its site on 30 November 2020.

The 46-year-old had been unpacking and moving the slabs onto storage racks, using an overhead crane, at the company's site in Halesowen.

Two of the slabs, each weighing 250kg, fell and crushed the worker against a forklift truck while he was operating the crane's handheld pendant control.He died at the scene despite desperate attempts from bystanders at nearby businesses and the emergency services to save him.

**HSE** 

A Health and Safety Executive (HSE) investigation found the company and its director failed to implement staff training or develop safe systems of work for the unloading, loading and handling of concrete slabs. There was no evidence that employees had received training in the safe operation of machinery, including the overhead crane. The overhead crane and forklift truck had also not been thoroughly examined, as required by law, and that webbing slings, that could have been used during the unpacking process, were damaged.

HSE guidance states employers must manage and control the risks to avoid any injury or damage during lifting operations. More on this can be found at: <u>Lifting Operations and Lifting</u> <u>Equipment Regulations (LOLER)</u> (hse.gov.uk

The company pleaded guilty to breaching Section 2(1) of the Health and Safety at Work etc. Act 1974. The company was fined £18,000 and ordered to pay £4,196.03 in costs at Dudley Magistrates' Court on 6 March 2024.



The company director pleaded guilty to breaching Section 37(1) of the Health and Safety at Work etc. Act 1974. He was ordered to complete 120 hours of unpaid work and pay £4,043.42 in costs at Dudley Magistrates' Court on 6 March 2024.

HSE inspector Mahesh Mahey said:

"This was an entirely preventable accident. The risks of lifting and moving granite slabs were obvious, yet could have been controlled by relatively simple and inexpensive measures. The company and director failed to adequately control lifting operations which resulted in an employee needlessly and tragically losing his life."

This prosecution was brought by HSE enforcement lawyer Andy Siddall and supported by HSE paralegal officer Rebecca Forman.

He has long been a pivotal figure within the materials handling industry and has an enviable track record in business management. To many he will be best known for the 19 years he has spent spearheading IMHX on behalf of Informa Markets as partners of UKMHA.



The annual LAMMA show is a fantastic opportunity for people to find out about the latest news in the industry, but also a chance to learn. At CFTS, we made it a priority to engage with as many attendees as possible at our stand.

Last year was our first time at LAMMA, and we were surprised by how many people didn't know about the importance of LOLER and PUWER. A number had heard of LOLER but not PUWER. This year was similar, highlighting the need for more education on these crucial regulations for a proper Thorough Examination.

We explained that understanding both is key to ensuring safety. The past two LAMMA shows have shown us that there's still a lot to do in educating the agricultural sector.

Agriculture has a high rate of fatal injuries, with HSE figures showing 27 fatalities from April 2022 to March 2023 – 21 times higher than the all-industry average. Provisional figures from April 2023 to March 2024 have the figure rising to a worrying 32 fatalities. These numbers highlight the need for better awareness of safety standards.

Let's work together to make the agricultural industry safer by understanding and following these essential regulations.

We'll be in attendance again in 2025 to continue engaging with this important audience and keep growing awareness.

## European Active Projects fined by Health and Safety Executive after worker perched on raised pallet at Ramsgate Harbour

In a recent incident, European Active Projects (EAP), a marine contractor involved in repairing Royal Navy warships, was fined £100,000 for severe safety breaches. This case underscores the critical importance of adherence to safety protocols and regulations to prevent hazardous situations.

#### At Ramsgate Harbour, two EAP workers used a pallet raised by a forklift as a makeshift platform to remove a heavy pressure washer from a boat. The workers, lacking proper scaffolding, dangerously balanced on the pallet without any safety harnesses or appropriate equipment.

This was filmed by a member of the public. The footage was forwarded to the Health and Safety Executive (HSE), which led to an investigation and subsequent prosecution of EAP for violating work at height regulations.

The HSE investigation revealed that EAP failed to properly plan the refurbishment work, leaving workers at risk without a safe method to remove equipment from the vessel's deck. The lack of supervision and inadequate safety measures could have resulted in a fatal fall.

EAP admitted to breaching Section 4(1) of the Work at Height Regulations 2005. Maidstone Magistrates' Court fined the company £100,000 and ordered them to pay £5,730 in costs. The court emphasised that the incident was entirely preventable with proper supervision and equipment, such as harnesses or a winching system.

The level of the fine meted out to European Active Projects should underline how severely these safety breaches are taken.

This incident highlights the vital role of safety standards in preventing workplace accidents. The actions of EAP were in direct contravention of the Health and Safety Executive's PM28 guidelines, which provide specific instructions on the safe use of non-integrated working platforms on forklifts. According to PM28, forklifts are primarily intended for lifting materials, not people, and their use with working platforms is only acceptable under exceptional circumstances with proper safeguards in place. EAP's use of a pallet as a platform without these precautions posed significant risks, violating these established safety protocols.

The application of the guidance laid out in PM28 is something that CFTS continues to stress the importance of during our Thorough Examination courses. It is never worth the risk. Always make sure you are following proper safety procedures.

Users of lifting equipment using maintenance cages will need a Thorough Examination on both the cage and the equipment to which it is fitted every six months.

Before the inception of the CFTS Thorough Examination scheme, the forklift industry faced a patchwork of varying standards and practices. This inconsistency often led to confusion and, more importantly, safety risks.

Recognising the need for a unified approach, the British Industrial Truck Association (BITA) and the Fork Lift Truck Association (FLTA) joined forces to create a comprehensive inspection standard that would become the backbone of the CFTS Thorough Examination scheme.

As two major – and competing – industry bodies, reaching a consensus was no small feat.

## David Ellison, former CEO of the FLTA, takes up the story:

"At the time, there was general confusion between the requirements of LOLER 98 and PUWER 98 – both fairly new regulations.

LOLER 98 was relatively complex and specialist. It covered everything from dumb waiters in restaurants, high speed lifts on the outside of buildings, and giant tower cranes operating in the middle of London.

PUWER 98 was more to do with the mechanical/automotive side of equipment, with some similarities to an MoT.

BITA and the FLTA wanted a single inspection regime that would cover the requirements of both LOLER and PUWER, and HSE was interested in this initiative.

HSE was willing to collaborate with BITA and the FLTA on a variation of the inspection scheme, provided they worked together. As a result, CFTS was created. This collaboration was crucial for the FLTA to ensure that the interests of smaller hiring and maintenance companies were properly considered.

I think the main difficulty was getting BITA and the FLTA to come together and agree much of the detail. Gill Male of the HSE was instrumental in helping this happen, and he was himself an experienced engineer and inspector.

He had direct input into the CFTS guidance and inspection documents. However, he always made it clear that HSE could not formally endorse CFTS or the associated Report of Thorough Examination. Thus, it was established with their full knowledge and blessing, but without formal endorsement."

Serious faults, such as poor brakes, worn steering components etc. had no bearing on the examination, and the inspectors did not have the equipment to check them anyway. We thought this was wrong.

Along came CFTS with a new – and much more comprehensive – set of procedures for carrying out the Thorough Examination. This gave the customer considerably more faith in the service that they were paying for – a truly Thorough Examination.

We were very quick to sign on the dotted line and become accredited to CFTS. It involved committing ourselves to abide by their standards and allow them to visit us and check our own procedures and record-keeping.

We truly believe the customer is in a much better place when they have a certificate with the CFTS logo on it."

Looking to the future, CFTS aims to integrate advanced diagnostic tools and digital record-keeping into the inspection process, making it more efficient and accessible. There is also a focus on expanding the scheme's reach to encourage more businesses across more industries to adopt CFTS Thorough Inspections.
